QUARTERLY FIRST PREFERENCE SHARES, SERIES 1 DIVIDEND**

**Toronto, March 5, 2009 – Dundee Corporation** (TSX: DC.A and DC.PR.A) announced today that its board of directors has approved the payment of a quarterly cash dividend of \$0.3125 per first preference share, series 1 payable on March 31, 2009 to shareholders of record on March 17, 2009.

The dividend is designated as an eligible dividend for the purposes of section 89 of the *Income Tax Act* (Canada).

Its domestic wealth management activities are carried out through its controlled subsidiary, DundeeWealth Inc.
