QUARTERLY FIRST PREFERENCE SHARES, SERIES 1 DIVIDEND**

Toronto, August 13, 2008 – Dundee Corporation (TSX: DC.A and DC.PR.A) announced today that its board of directors has approved the payment of a quarterly cash dividend of \$0.3125 per first preference share, series 1 payable on September 30, 2008 to shareholders of record on September 16, 2008.

The dividend is designated as an eligible dividend for the purposes of section 89 of the *Income Tax Act* (Canada).
